USES

EVO-STIK Rear View Mirror Adhesive is a single part structural anaerobic adhesive. It is designed for bonding metals to glass such as rear view mirrors, glass mounted 'phone aerials and metal catches to glass windscreens. It cures rapidly when in firm contact with its catalyst impregnated mesh, in the absence of oxygen.

DIRECTIONS FOR USE

IMPORTANT: Before using EVO-STIK Rear View Mirror Adhesive refer to the relevant Health & Safety Data Sheet, available at www.bostik.co.uk.

PREPARATION

- Ensure both surfaces to be bonded are clean, dry and free from grease. It is important to remove the remains of any previous adhesive.
- Work in warm conditions. Both surfaces and air temperature should be between +18°C and +23°C for best results.
- 3. Mark where the mirror or aerial is to be fitted on the windscreen.
- 4. Trim the mesh to the shape of the foot of the mirror or aerial mounting.

APPLICATION

- 5. Apply the adhesive to the foot of the mirror or aerial mounting, evenly covering the area of contact with a thin coat of adhesive.
- 6. Place the mesh on the adhesive then immediately mount the mirror or aerial onto the marked position on the windscreen.
- 7. Hold firmly in place for 2 minutes.

CLEANING

- 8. Carefully remove excess wet adhesive with a dry cloth.
- 9. Any film residues may be removed with a clean cloth dampened with a small amount of solvent.
- 10. When using solvent cleaners always test on a small area first. Do not use solvents in contact with the skin.
- 11. To remove the adhesive from the skin using a suitable propriety hand cleaner.

PRECAUTIONS IN USE

Cure Times will be greatly extended below 18 $^{\circ}$ C, also poorer quality bonds will result. Contaminants left on surfaces may slow the cure rate.
