### DESCRIPTION

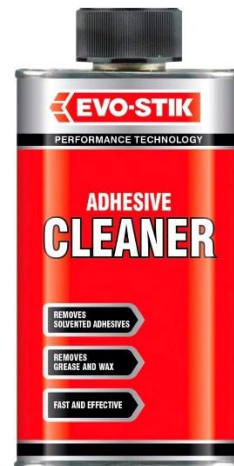
EVO-STIK Adhesive Cleaner is a mixture of solvents for cleaning the residue from solvented adhesives. EVO-STIK Adhesive Cleaner can tackle wet or dry adhesive and even small areas of old adhesive can be removed.

It is ideal for cleaning substrates prior to bonding, in particular rubber, metals and many other impervious surfaces. It is also ideal to clean adhesive from equipment and to remove small dried deposits of contact adhesives from surfaces. It is also possible to dilute EVO-STIK 528 Contact Adhesive and EVO-STIK Impact Adhesive for priming very porous substrates. To prime, dilute 50:50 adhesive and cleaner.

EVO-STIK Adhesive Cleaner is not suitable for use on polystyrene, cellulose paint, vinyl, and rayon fabrics.

### APPLICATION

### PREPARATION

- Always test the effects of the cleaner on an unseen or test area to determine its suitability; it may damage some sensitive surfaces.
- Open any windows and doors to ensure good ventilation. Push down and unscrew to remove cap, puncture silver seal using a sharp object such as a screwdriver. Ensure container is properly sealed after use.

### APPLICATION

- Wearing gloves use cloths made into pads and moisten them with the cleaner. Use the pad to wipe over the adhesive to be removed.
- In the case of rubbers, particularly black rubbers, some of the black may appear on the cloth; this is normal.
- Always repeat the process with another clean pad moistened with cleaner.

- For removing larger areas of adhesive it is best to use a new cloth at frequent intervals.
- The use of a number of washings with small quantities of cleaner is far more efficient than a single large washing.
- Leave cloths outside until fully dry before disposal.

Removal of Dried Adhesive:

- Always try to minimize the amount of cleaner used.
- Therefore, attempt to remove the bulk of the material to be cleaned by mechanical means as this will drastically reduce the amount of cleaner required.

N.B This cleaner is not designed to remove old deposits of adhesive from ceilings, walls and floors. The cleaner cannot stay in contact with the adhesive long enough to soften the deposits before the solvent runs away or evaporates.

Priming very Porous Substrates:

- Only prepare enough for immediate use.
- Dilute EVO-STIK 528, EVO-STIK 613 or EVO-STIK Impact Adhesive (see separate product data sheets) with an, approximately, equal volume of EVO-STIK Adhesive in a clean container. Dispose of any leftover mixture.
- Always add cleaner to adhesive, slowly, with gentle stirring.
- Stir well.

**STORAGE**

- Store for up to 24 months when stored in original, unopened packaging under cool dry conditions within the temperature range of +15°C to +30°C.

**PRECAUTIONS IN USE**

Work in a very well-ventilated area and avoid breathing the vapours. Ensure that any source or potential source of ignition is removed / isolated.

Always test the effects of the cleaner on an unseen or test area to determine its suitability; it may damage some sensitive surfaces.

Always try to use the minimum amount of cleaner/solvent.

Always wear gloves and safety glasses.
